Note A: As at 1 January 2017, our Post-IPO Share Option Scheme had 258,988,247 stock options outstanding. During the month of January 2017, Nil stock options were granted, Nil options were exercised, 6,302,300 stock options were forfeited and Nil stock options expired. As at 31 January 2017, our Post-IPO Share Option Scheme had 252,685,947 stock options outstanding, of which 121,044,080 stock options were vested (Nil stock options were vested in the month of January 2017) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note B: Private placement of 60,000,000 shares issued at HKD 0.262 closed on January 24, 2017. This issuance was under the General Mandate approved at the Annual General Meeting held on June 30, 2016.
