Remarks (if any):

Note A: As at 1 February 2014, our Pre-IPO Share Option Scheme had 72,825,686 stock options outstanding. During the month of February 2014, Nil stock options were exercised and Nil stock options were forfeited. As at 28 February 2014, our Pre-IPO Share Option Scheme had 72,825,686 stock options outstanding, of which 72,825,686 stock options were vested (66,666 stock options vested in the month of February 2014) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note B: As at 1 February 2014, our Post-IPO Share Option Scheme had 56,812,004 stock options outstanding. During the month of February 2014, Nil stock options were granted and 306,301 stock options were forfeited. As at 28 February 2014, our Post-IPO Share Option Scheme had 56,505,703 stock options outstanding, of which 29,884,802 stock options were vested (1,227,320 stock options were vested in the month of February 2014) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note C: The purpose of the Employee Share Savings Plan (the “Plan”) approved at the Company’s Annual General Meeting on 7 May 2013, is to provide an opportunity for employees of the Company to purchase Class “A” Common Shares (“Shares”) from the Company’s treasury at the Market Price (as defined by the Plan) through voluntary automatic payroll deductions, thereby attracting, retaining, encouraging and rewarding employees to use their combined best efforts on behalf of the Company and to ensure that employees have a share in the increased profitability and value of the Company. The Company will support the acquisition of Shares by employees pursuant to the Plan through matching employee contributions to the Plan within certain limits defined by the Plan. Contributions by employees and the Company will be made for the purchase of Shares on a regular basis. On 28 February 2014, 349,659 new Shares were issued pursuant to the Plan.

Note D: Each whole warrant entitles the subscriber to acquire one Class “A” Common Share at an exercise price of HKD 1.88 per Class “A” Common Share, for a period of 24 months following the closing date of the Unit offering which included one Class “A” Common Share and one third of one warrant per Unit. As at 1 February 2014, the Company had 144,751,372 warrants outstanding. During the month of February 2014, there were 30,217,986 warrants given to subscribers as part of the Unit offering and an additional 36,261,583 were given to Second Finders of the subscriptions as referred to in the Company’s announcement dated 7 February 2014 and 28 February 2014. At 28 February 2014 there were 211,230,941 outstanding.

Note E: Placement of 45,000,000 and 45,653,958 Class “A” Common Shares which closed on the 7 February 2014 and 28 February 2014 respectively.
