Note A: As at 1 May 2014, our Pre-IPO Share Option Scheme had 72,825,686 stock options outstanding. During the month of May 2014, Nil stock options were exercised and Nil stock options were forfeited. As at 31 May 2014, our Pre-IPO Share Option Scheme had 72,825,686 stock options outstanding, of which 72,825,686 stock options were vested (Nil stock options vested in the month of May 2014) and available for exercise into Class "A" common shares on a 1 for 1 basis.

Note B: As at 1 May 2014, our Post-IPO Share Option Scheme had 54,428,573 stock options outstanding. During the month of May 2014, Nil stock options were granted and 265,791 stock options were forfeited. As at 31 May 2014, our Post-IPO Share Option Scheme had 54,162,782 stock options outstanding, of which 31,088,396 stock options were vested (476,921 stock options were vested in the month of May 2014) and available for exercise into Class "A" common shares on a 1 for 1 basis.

Note C: The purpose of the Employee Share Savings Plan (the "Plan") approved at the Company's Annual General Meeting on 7 May 2013, is to provide an opportunity for employees of the Company to purchase Class "A" Common Shares ("Shares") from the Company's treasury at the Market Price (as defined by the Plan) through voluntary automatic payroll deductions, thereby attracting, retaining, encouraging and rewarding employees to use their combined best efforts on behalf of the Company and to ensure that employees have a share in the increased profitability and value of the Company. The Company will support the acquisition of Shares by employees pursuant to the Plan through matching employee contributions to the Plan within certain limits defined by the Plan. Contributions by employees and the Company will be made for the purchase of Shares on a regular basis. On 30 May 2014, 428,427 new Shares were issued pursuant to the Plan.
