Remarks (if any):

Note A: As at 1 September 2016, our Pre-IPO Share Option Scheme had 977,080 stock options outstanding. During the month of September 2016, Nil stock options were exercised, 48,200 stock options were forfeited and 778,800 stock options expired. As at 30 September 2016, our Pre-IPO Share Option Scheme had 150,000 stock options outstanding, of which 150,000 stock options were vested (Nil stock options vested in the month of September 2016) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note B: As at 1 September 2016, our Post-IPO Share Option Scheme had 114,895,156 stock options outstanding. During the month of September 2016, 158,236,861 stock options were granted, 241,666 options were exercised, 6,525,721 stock options were forfeited and Nil stock options expired. As at 30 September 2016, our Post-IPO Share Option Scheme had 266,364,630 stock options outstanding, of which 120,882,949 stock options were vested (60,726,353 stock options were vested in the month of September 2016) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note C: Each whole warrant entitles the subscriber to acquire one Class “A” Common Share at an exercise price of HKD 1.88 per Class “A” Common Share, for a period of 24 months following the closing date of the Unit offering which included one Class “A” Common Share and one third of one warrant per Unit. As at 1 September 2016, the Company had Nil warrants outstanding. During the month of September 2016, there were Nil warrants issued, Nil warrants exercised and Nil warrants expired. At 30 September 2016 there were no warrants outstanding.
