**Note A: As at 1 December 2012, our Pre-IPO Share Option Scheme had 140,116,720 stock options outstanding. During the month of December 2012, 13,789,000 stock options were exercised and 1,366,120 stock options were forfeited. As at 31 December 2012, our Pre-IPO Share Option Scheme had 124,961,600 stock options outstanding, of which 116,699,867 stock options were vested (1,872,040 stock options vested in the month of December 2012) and available for exercise into Class “A” common shares on a 1 for 1 basis.**

**Note B: As at 1 December 2012, our Post-IPO Share Option Scheme had 31,778,180 stock options outstanding. During the month of December 2012, 35,824,908 stock options were granted and accepted and 59,000 stock options were forfeited. As at 31 December 2012, our Post-IPO Share Option Scheme had 67,544,088 stock options outstanding, of which 12,472,663 stock options were vested (1,899,603 stock options vested in the month of December 2012) and available for exercise into Class “A” common shares on a 1 for 1 basis.**

**Note C: According to the conversion schedule disclosed in the audited financial statements for the year ended 31 December 2011 (note 12), the total Class “G” and Class “H” preferred shares were available at a conversion rate of 46% based on the vesting terms. During the month of December 2012, Nil vested Class “G” preferred shares were converted into Nil Class “A” common shares at the conversion rate of 46%. The ending balance of Class “G” and Class “H” preferred shares outstanding as at 31 December 2012 was 60,440,000 and 22,200,000, respectively, which if converted, would result in the issuance of a total of 38,014,400 Class “A” common shares (27,802,400 if converted from Class “G” preferred shares and 10,212,000 if converted from Class “H” preferred shares).**
