Remarks (if any):

Note A: As at 1 December 2015, our Pre-IPO Share Option Scheme had 6,617,080 stock options outstanding. During the month of December 2015, Nil stock options were exercised, Nil stock options were forfeited and 1,240,000 stock options expired. As at 31 December 2015, our Pre-IPO Share Option Scheme had 5,377,080 stock options outstanding, of which 5,377,080 stock options were vested (Nil stock options vested in the month of December 2015) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note B: As at 1 December 2015, our Post-IPO Share Option Scheme had 94,327,424 stock options outstanding. During the month of December 2015, Nil stock options were granted, Nil options were exercised, 1,093,911 stock options were forfeited and 3,055,807 expired. As at 31 December 2015, our Post-IPO Share Option Scheme had 90,177,706 stock options outstanding, of which 66,309,635 stock options were vested (9,008,276 stock options were vested in the month of December 2015) and available for exercise into Class “A” common shares on a 1 for 1 basis.

Note C: The Employee Share Savings Plan was discontinued by the Company on 31 August 2015.

Note D: Each whole warrant entitles the subscriber to acquire one Class “A” Common Share at an exercise price of HKD 1.88 per Class “A” Common Share, for a period of 24 months following the closing date of the Unit offering which included one Class “A” Common Share and one third of one warrant per Unit. As at 1 December 2015, the Company had 211,230,941 warrants outstanding. During the month of December 2015, there were Nil warrants issued, Nil warrants exercised and 78,320,000 warrants expired. At 31 December 2015 there were 132,910,941 warrants outstanding.
